HAVING REGARD to Presidential Decree 28.12.2000, no. 445;

HAVING REGARD to Articles 2 and 12 of Prime Ministerial Decree of 9 April 2001, "Equal treatment in the right to university studies";

HAVING REGARD to the Regulation for Administration, Finance and Accounting, issued by Rector's Decree no. 828 ref. no. 7766 of 14/03/2014 and in particular Art. 75 and 79;

HAVING REGARD to the letter, ref. no. 228922/2025 of 29/09/2025, with which the attorneys Paolo Benzi e Iulia Mihnea of the Company Dalmine S.p.A. manifested the intention to donate, merely for charitable purposes, to Politecnico di Milano, the sum of €30,380.00 aimed at promoting study activity in the field of engineering through the payment of 10 scholarships entitled "Roberto Rocca", intended for students registered in the a.y. 2025/2026 on the 1st and 2nd year of the Master's degree course in Engineering at Politecnico di Milano;

HAVING REGARD to Managerial Decree no. 17334/2025 Protocollo 230723/2025 of 30/09/2025 which declares to accept the donation provided by the company Dalmine S.p.A.;

DECREES

The issuance of the call for applications for **10 "Roberto Rocca" scholarships a.y. 2025/2026**.

Art. 1

Recipients and characteristics of the scholarships

The **10 scholarships of €2,800.00 gross each**, net of costs borne by Politecnico di Milano, are intended for students enrolled in the a.y. 2025/2026 on Master's degree courses in Engineering at Politecnico di Milano.

Art. 2

Admission requirements

The scholarships are broken down as follows:

NO. 5 SCHOLARSHIPS FOR STUDENTS ENROLLED IN A.Y. 2025/2026 (1 LM) in possession of the following requirements at the call deadline:

1. enrolment in the a.y. 2025/2026 on Master's degree courses in:
 - Automation and Control Engineering
 - Chemical Engineering - Ingegneria Chimica
 - Computer Science and Engineering
 - Electrical Engineering
 - Electronics Engineering
 - Energy Engineering
 - Management Engineering
 - Materials Engineering and Nanotechnology
 - Mechanical Engineering
2. registered in the a.y. 2025/2026 on the aforementioned degree courses
3. at least 15 CFU which have been duly passed and registered on the student's record and are eligible for the purposes of graduation (including validations)
4. weighted average not less than 27/30 of examinations which have been duly passed and registered on the student's record and are eligible for the purposes of graduation (including validations)
5. residence in Italy;

NO. 5 SCHOLARSHIPS FOR STUDENTS ENROLLED IN THE A.Y. 2024/2025 (2 LM) in possession of the following requirements at the call deadline:

1. enrolment in the a.y. 2024/2025 on Master's degree courses in:
 - Automation and Control Engineering - Ingegneria dell'Automazione
 - Chemical Engineering - Ingegneria Chimica
 - Computer Science and Engineering - Ingegneria Informatica
 - Electrical Engineering - Ingegneria Elettrica
 - Electronics Engineering - Ingegneria Elettronica
 - Energy Engineering - Ingegneria Energetica
 - Management Engineering - Ingegneria Gestionale
 - Materials Engineering and Nanotechnology - Ingegneria dei Materiali e delle Nanotecnologie
 - Mechanical Engineering - Ingegneria Meccanica
2. registered in the a.y. 2025/2026 on the aforementioned degree courses
6. at least 60 CFU which have been duly passed and registered on the student's record and are eligible for the purposes of graduation (including validations)

7. weighted average not less than 27/30 of examinations which have been duly passed and registered on the student's record and are eligible for the purposes of graduation (including validations)
3. residence in Italy;

Fundraising and Alumni Unit will verify whether the requirements have been met using the Politecnico di Milano's digital archive.

It is the applicant's responsibility to ensure that the data present in the Politecnico di Milano's digital archive are correct and current by the deadline of this call for applications.

Art. 3 How to participate

Applicants are required to submit the application by way of the specific function available from Online Services <http://www.polimi.it/servizionline> (Benefits and agreements> Economic benefits) **from 15 January 2026 to 27 March 2026 at 12 pm noon (Italian time).**

Applicants must attach, via the specific procedure, in PDF format with a maximum of 5 MB:

1. Curriculum Vitae et Studiorum

The files must be named as Surname-Name-Type of document.pdf (for example Rossi-Mario-CV.pdf)

Upon completion of the online application process (status: closed), the application to this call shall be deemed to have been submitted and the applicant shall be understood to have agreed to the contents of the call itself.

It is the applicant's responsibility to check that the process has been completed correctly.

After having completed and submitted the application, the applicant may print a receipt and the application may no longer be altered. The applicant may delete and resubmit the application at any time before the deadline of this call for applications.

Failure to complete the application, the submission of an incomplete application or the submission of inadequate documents shall result in the applicant being excluded from the assessment process.

Art. 4 Assignment of the scholarship

The assignment of the scholarship will be decided by a Selection Committee appointed after the call deadline by management decree.

An initial ranking will be formulated for each category, taking account of the financial status, giving priority to the applicant in the most disadvantaged economic conditions.

To that end, the valid and compliant 2026 ISEE (equivalent ISEEU for those not earning income in Italy), found in the University's database by the call deadline will be considered.

In the absence of a valid and compliant 2026 ISEE (Equivalent Economic Situation Indicator)/ISEEU the student will be attributed, solely for the purposes of this ranking, the highest ISEE/ISEEU (€95,001).

In the case of equal scores, the youngest applicant will be favoured.

The top 12 applicants of each category will be admitted to undergo interview with the Selection Committee in order to assess the cross-sectional skills and expertise possessed.

The final ranking will be prepared by the Selection Committee based upon the outcome of the interview.

The calendar of interviews will be communicated following the publication of the first ranking.
The interviews will be held, in Italian, preferably in presence and approximately in May.

The interviews in the presence, will be in di Dalmine (BG), p.za Caduti 6 luglio 1944, n.1.

The Selection Committee may not assign all scholarships or part of them, if all or part of the applicants are not considered suitable.

The winners may be invited to a get-to-know meeting with the donor.

Art. 5

General rules

Cumulation: the scholarship and any renewals cannot be combined with other scholarships or other forms of financial aid provided by Politecnico, in particular with Diritto allo Studio Universitario (DSU) financial aid for the academic year in question. The scholarship and its renewal may be combined with international mobility benefits provided by Politecnico or other public or private entities. The scholarship and its renewal may also be combined with exemptions from tuition fees and contributions.

Payment: the winner of the scholarship will be notified about the award and any renewals through his/her University e-mail address. Within 10 days of receiving said notification, the winner must sign and return the corresponding forms attached to the award and renewal notifications.

The scholarship will be disbursed by Politecnico di Milano in a single payment.

In the event that the scholarship is not awarded and/or the holder fails to renew the scholarship, the remaining funds will be used to establish a new call for applications.

Withdrawal: in the event that the winner withdraws and/or fails to return the required forms by the relevant deadline, the scholarship will be awarded to the next eligible applicant in the ranking.

Revocation: the scholarship may be revoked if disciplinary sanctions are brought against the recipient. In any case, the scholarship will be revoked if the recipient withdraws from his/her studies or transfers to another University during the year.

Revocation will require the amount received to be returned to Politecnico di Milano and the amount will be used to set up a new call for applications.

Self-certification: Politecnico di Milano will verify the recipient's declarations and any false declarations will result in the forfeiture of any benefits awarded.

Taxation: the scholarship will be subject to taxation, in accordance with current legislation relating to scholarships. The amount paid by way of scholarship shall be treated as employment income for tax purposes and shall therefore be subject to the same tax arrangements. The costs to be borne by Politecnico di Milano are the IRAP regional tax on production activities, amounting to 8.5% of the scholarship amount.

PERSONAL DATA COLLECTED

The personal data regarding you collected and processed by Politecnico are (a) the data provided by you upon registration or enrolment, such as name, surname, date and place of birth, sex, tax code, nationality, residential address, telephone and email contact details, educational qualifications; (b) the data collected upon submitting your application, particularly those relating to your academic career in number of university credits and average.

DATA PROCESSING PURPOSES AND METHODS

Your personal data may be processed for the following purposes:
for the public interest of verifying requirements for participation in the competition according to the criteria set forth in this call for applications and all other legal purposes, including statistical.

In relation to the aforesaid purposes, the data will be processed by Politecnico di Milano using manual, computerised and electronic tools, in a manner pertinent and limited to what is necessary with respect to the purposes for which the data are processed, and in any case in such a way as to guarantee the utmost security and confidentiality and always in full compliance with current legislation.

SCOPE OF CIRCULATION AND COMMUNICATION OF DATA

Your data will also be communicated to the donor to inform it of the outcome of the call.

STORAGE AND POSSIBLE TRANSFER OF PERSONAL DATA

Your personal data will be stored at Politecnico di Milano and will not be transferred to a third country.

DATA STORAGE PERIOD

Your personal data will be stored only for as long as strictly necessary in order to meet the requirements of this call for applications, unless it becomes necessary to retain and store the data for a longer period in the public interest. If the data are stored for longer periods, Politecnico guarantees compliance with the data minimisation principle under Art. 89, point 1 of the Regulation.

YOUR RIGHTS
